



# West Dowling Road Phase II: C Street to Minnesota Drive

The Alaska Department of Transportation and Public Facilities (DOT&PF) is in the early design stage of the West Dowling Road Phase II project.. The project aims to decrease congestion and improve east-west mobility in the area between C Street and Minnesota Drive.

### Purpose:

The extension will provide east-west traffic flow, reduce traffic on Tudor Road and Dimond Boulevard, and help develop a more connected roadway pattern as identified in the Anchorage Long Range Transportation Plan (LRTP). The LRTP identifies the West Dowling Road Extension as a top-priority project for shaping Anchorage's future.

### Background:

The idea of connecting West Dowling Road between the Old Seward Highway and Minnesota Drive has been considered for many years. Work began on an Environmental Assessment

(EA) in 2002. The EA, completed in 2007, recommended the Rovenna alternative for construction. The project area was divided into Phase I and Phase II in 2008. DOWL HKM was selected to complete Phase I: Old Seward Highway to C Street and HDR Alaska was chosen to complete Phase II: C Street to Minnesota Drive.

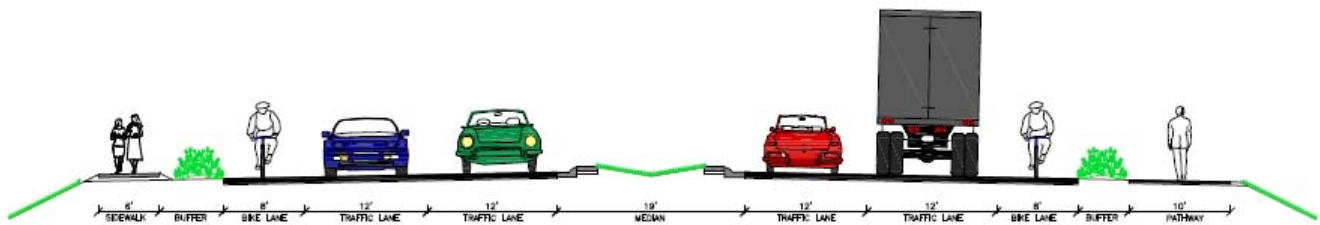


### Environmental Review Process:

Potential impacts on the physical, biological, and human resources along multiple routes between the Old Seward Highway and Minnesota Drive were considered in the 2002-2007 Environmental Assessment. Four possible routes were eliminated from the study for several reasons, including inability to address the project's needs, significant community impacts, and /or significant environmental impacts.

### Components of Phase II:

Phase II: C Street to Minnesota Drive is a new road connection that follows the "Rovenna concept" identified in the 2007 Environmental Assessment. The new road will be a four-lane roadway—two lanes in each direction with a depressed center median and turn-pockets. The project also includes a new intersection at Raspberry Road and 68th Avenue, street lighting, two on-street bike lanes, a six-foot sidewalk, and a 12-foot separated pathway. A bridge will cross over Arctic Boulevard and the rail-road tracks.



### Schedule:

The preliminary design will be completed and permits obtained in early 2010. Final design will be finished in 2011, and the project is scheduled to begin construction in the summer of 2012.

### Opportunities for Involvement:

DOT&PF will keep the public informed about the project and provide opportunities for input throughout the design process. Public meetings will occur at major stages in the project's development.
